<b>IMPORTANT INFORMATION</b>		
3.	<b><u>Eligibility:</u> Who may enter the Competition?</b>	To enter the Competition, a participant (“ <b>Participant</b> ”) will be required to, for the duration of the Competition period, comply with the following: I. the Competition is open to all South African, Gauteng residents who are 18 years and above; and II. who are in possession of a valid identity document or passport;
